Submission

The articles submitted to the journal should be in accordance with the aim and scope of the journal. Manuscripts should be submitted electronically via email to: splintjournal@gmail.com and submitted as a single MS-word file including all materials. Any opinions expressed in articles are only those of authors and not necessarily those of the editorial board. Further, all authors submitting papers to the journal need to provide the final data used in the paper and computer codes (if they have developed it or if they used existing codes, proper source and all modifications need to be stated) for replication purpose, if requested by the reader. We favour for the open source data and this is to validate the results reported in the paper.

Article

Article must be unpublished. The title page must include an abstract with keywords that is no longer than 200-250 words, full contact information with individual telephone nos. of all authors, communication address, affiliation etc. References must strictly meet the journal's style requirements. The complete article should not exceed 5000 words. The author(s) can contribute one article for publication and the same author (s) can not be a co-author for any other article in the same issue and vice versa. Any word(s) to be abbreviated should be written in full when first mentioned followed by the abbreviation in parenthesis.

Reference Style

References should be cited in the text as name and year and listed at the end of the paper alphabetically. Where reference is made to more than one work by the same author published in the same year, identify each citation in the text as follows: (Tiwari, 2013a, 2013b). Where three or more authors are listed in the reference list, please cite in the text as (Tiwari et al., 2012a, 2012b). All references must be complete and correct. Online citations should include date of access. References should be listed in the following style:
